Scope

Collection of Personal information

We have a secure connection FSL certificate to encrypt personal information collected. Any personal information held in our database is held at a secure third party data centre with state of the art security measures to ensure the privacy of our customers. If you purchase with us or create an account, we will collect your name, phone number, email address, mailing address and any other critical information specific to the delivery of our products. When purchasing with PayPal or a credit card, cardholder data is not stored on the server, only transmitted to the payment gateway at the time of a purchase. This data transmission is encrypted (please see Website Terms & Conditions for further information).
